- I. Scholarships are provided for the purposes of facilitating international education and enrolling international students with excellent academic standing at National Chin-Yi University of Technology (the “University”), and encouraging them to pursue their studies.
- II. Recipients: Starting from the 2026 academic year, international students (excluding students from the International Bachelor Program, INTENSE Program, Hong Kong, Macau, and Mainland China, as well as overseas Chinese students, exchange students and Dual Degree Program students who are officially enrolled in undergraduate programs at the University). Applicants must have studied at the university for two semesters or more (i.e. Year 2 to Year 4) and not received any government scholarships (excluding students on an extension of their studies and graduate students).
- III. Academic Performance Requirements: An evaluation shall be conducted once per semester. Applicants must meet all of the following criteria to be deemed eligible:
 - (1) Undergraduate students must enroll in at least nine credits in the semester of application, rank within the top 50% (inclusive) of their class in academic performance, have no failing grades in any course, and have no course grades pending submission.
 - (2) Applicants must not have received a disciplinary warning or any higher-level disciplinary action, nor have been subject to any disciplinary penalties per the University’s regulations.
 - (3) Applicants must have obtained a Physical Education grade of 70 or above (excluding students exempted from or auditing Physical Education courses).
 - (4) Applicants must have fully paid all tuition and miscellaneous fees, National Health Insurance premiums, and any other required fees for the semester concerned.
- IV. Scholarship award: Successful applicants will receive a scholarship of \$10,000 per semester.
- V. The academic affairs unit of the relevant undergraduate program shall submit a list each semester of students who meet the scholarship criteria. The list shall be jointly reviewed by the student affairs unit (students who have already withdrawn from the University shall not be eligible for consideration, and vacancies shall not be filled by alternates). Following review, the list shall be submitted to the President of the University for approval before scholarships are awarded.
- VI. Those who have already been awarded a scholarship under the Guidelines are not eligible to apply for other similar scholarship at the University.
- VII. Funding sources: Scholarships are awarded from the University Student Financial Aid

Fund and subsidies from the MOE.

- VIII. The Guidelines shall enter into effect from the date of promulgation following ratification by the University Student Financial Aid Committee. The same shall apply to all future amendments.
